It is calculated by means of the Margolies-equation  $M = 5.37 \times 10^4 \times [\eta]^{4.49}$ , with  $[\eta]$  being the intrinsic viscosity (Staudinger index) derived from a viscosity measurement according to ISO 1628-3:2001, using decahydronaphtalene as a solvent (concentration of 0.0002 g/cm<sup>3</sup>).
